business plan and the meeting was attended by the National Grid Sufficiently Independent Directors, Catherine Bell and Clive Elphick.
Firstly, we looked at benchmarking which covered both Capex and Opex. This was followed by a deep dive on NGET's load and no load investment plans. The topics covered were Reliability, Energy System of the future and Connect to the Network. The Stakeholder Group were taken through the engagement undertaken for each topic and the associated outcomes and indicative costs. The Stakeholder Group challenged NGET to ensure that consumer benefits were linked to evidence. Other challenges included a need for NGET to ensure that the business plan set out clear explanations of the uncertainty mechanisms that were being proposed with respect to connections and to also provide a definition for whole systems. The final session was on incentives which looked at the RIIO 1 journey and ambition and proposals for RIIO 2.
The independent stakeholder user group have a meeting in May, in order to start the writing of our report. This will be followed by a meeting in June on the full NGGT business plan, in advance of submission to Ofgem and their challenge Group.
